Transport personnel and equipment to location.	Legal and security considerations of transporting firearms and ammunition to location of operations. Vehicle breakdown.	Personnel will travel by road in safe well maintained vehicles with firearms and ammunition carried separately in locked box. All vehicles are equipped with UHF radio, satellite phone, mobile phone and EPIRB in case of vehicle breakdown, accident or injury.
Communicate with responsible person to inform timings and locations of operations.	Inability to communicate with responsible person timings and locations of operations.	If unable to communicate with responsible person regarding timings and locations of shooting operations then the cull will be postponed for safety reasons.
Ground shooting of specified target species.	Accidental death or injury of persons or animals.	Only the specified target specie will be shot and only if a safe background exists and range is ideal to ensure a clean humane dispatch as per RSPCA doctrine. Only appropriate caliber ammunition will be used for the target specie.
Collection and disposal of target species.	Infection of personnel from deceased animals.	Once shot a deceased animal will be handled with gloves and relocated to a predetermined and prepared burial site and the site will be soil covered at the completion of the cull.
Data recording of target species.	Failure of data recording device.	Secondary data recording devices are always carried in the vehicle.
